BID DESCRIPTION: Provision of Sports Psychologist Services for a period of three (3) years.

CSA is the national governing body for the sport of cricket in South Africa and administers all aspects of South African cricket, men and women, both in the professional and amateur spheres.

NATURE OF SERVICE REQUIRED

Cricket South Africa (“CSA”) would like to invite suitably qualified sports psychologist to submit proposal for the provision of Psychological and Performance Coaching Services and CSA’s Match Officials Structures. Interested bidders should have at least three years proven records within the sporting environment and working with high performance and top athletes and coaches, and school kids.

NB: Interested bidders should have at least three years proven company records towards Sport Psychology.

BRIEF SPECIFICATION:

- Work with a broad range of amateur to elite umpires, groups, coaches and referees across the match officials Pipeline.
- Develop tailored interventions to assist umpires in preparation for competition and to deal with the psychological demands of the sport.
- Developmental strategies that enable these umpires to cope with and overcome setbacks, errors, poor performance and failures.
- Help them to manage on and off-field pressure, anxiety and stress related to performance.
- Identify mental strengths and weaknesses that contribute to or affect the individual’s performance.
- Facilitate counselling and/or workshops that focus on goal setting, visualization and relaxation.
- Improve focus and deal with distractions and expand their potential.
- Advise on how to improve squad, group cohesion, communication and motivation.
- Deliver group workshops on areas such as self-analysis of performance or techniques to develop mental skills within the sport.
- Deliver workshops on diversity

- Assess players and give feedback
- Conduct life skills sessions for age group players.
- Offer support to age group players
- Required to facilitate a group session or two at the umpire's annual conference.
