INVITATION TO BID.

BID DESCRIPTION: CSA/23/2023/24 – Technical and Sound Supplementation for Match Day, CSA HQ and COE Events

CSA is the national governing body for the sport of cricket in South Africa and administers all aspects of South African cricket, men and women, both in the professional and amateur spheres.

NATURE OF SERVICE REQUIRED

Cricket South Africa (“CSA”) would like to invite suitably qualified sound companies to submit a proposal for the provision of technical and sound supplementation services for a period of 2 years.

NB: Interested bidders should have at least 5 years’ experience in Technical and Sound support

BRIEF SPECIFICATION:

CSA requires a proposal that articulates the approach to delivering on the objectives with a focus on (but not limited to):

- Sound supplementation reinforcement to cover all areas of the grandstands from the bottom to top.
- 10 clusters with Sub woofers to be added to enhance the bass. (Subject to venue recce assessment and report recommended numbers).
- DO NOT rely on installed stadium sound, audio visual and lighting as many stadia struggle with their systems and are not working at 100% capacity.
- Ensure that the stadium sound system is set at the correct levels to compliment the supplementation reinforcement system to achieve good sound quality level is delayed correctly.
- Minimum of Three (3) x Microphones per system (one for DJ, one for MC and one for backup.) One mic must have a long range so that the MC can walk anywhere on the field or in the stands.
- A cabled link to and from the outside broadcast vehicles is to be provided for the anthems and whatever return feed is sent by broadcasters as necessary.
- Playback system for the anthems is required as this is a critical factor for live broadcast and streaming (as necessary from time to time). Note: The broadcasters rely on the suppliers feed for this so reliability and quality is important.
