







## Declaration of Good Standing

**Cricket South Africa (CSA)**, as the custodian/ national governing body for the sport of cricket in South Africa, strongly believes that safeguarding cricketers from harassment and abuse in sport should be the collective concern of all South African cricket stakeholders. Harassment and abuse have no place in sport or in society. By standing together, with all cricket participants and role-players, we can make South African cricket a better and safer place for all cricket stakeholders involved in the sport irrespective of level of involvement.

CSA therefore expects all “**Participants**” as stipulated below (*excluding the participating players/ cricketers*) appointed in a position of trust and who are expected to maintain a level of integrity, honesty, and commitment to the **CSA Safeguarding Policy and Code of Ethics** to sign a **Declaration of Good Standing**:

-  Any coach, trainer, manager, selector, official, doctor, medical personnel, physiotherapist or any other person who is employed by, represents or is otherwise affiliated to a team or squad;
-  Any CSA Official, Match Referee, Pitch Curator, Player Agent, Umpire or Umpire Support Personnel.
-  Any other individual who participates in any official capacity, on behalf of the CSA, a Provincial Cricket Federation or CSA Event organising committee, during the course of the Event;
-  Any other person who is engaged directly or indirectly in any activity on behalf of CSA, a Provincial Cricket Federation or CSA Event organising committee, in relation to the organisation or administration of the Event.

### Declaration of Good Standing

I acknowledge that to be a person in good standing of all aspects of **Cricket South Africa**, I must be of good character and comply with the CSA appointment criteria.

To my knowledge, I have no criminal record against my name. I have never been accused, charged or convicted of an offence relating to physical and mental abuse and or sexual offences against a underaged child/ minor or vulnerable adult. I further declare that I fully understand and am cognisant with the content of the **Cricket South Africa Code of Ethics For Cricket Coaches In South Africa** and will abide by and implement the core ethical values as stipulated in the code.

By answering “**NO**” to all the above questions, I hereby certify that I am of good character and am qualified to be a member in good standing with Cricket South Africa. I further warrant that I know of no circumstances whatsoever that would call into question my fitness to be a member in good standing with Cricket South Africa.

I declare that the information in this declaration is true to the best of my knowledge and there is no information that I am aware of that may undermine my good character.

I also acknowledge that by making this declaration I understand Cricket South Africa’s Policies and agree to be bound by its terms. I understand that failure to comply with the Cricket South Africa’s Safeguarding Policies may result in disciplinary sanctions or, in extreme cases, expulsion from Cricket South Africa and / or Provincial Affiliates and member affiliate Clubs and Schools to which I am affiliated.

I understand that any false statement or misrepresentation may disqualify/ prohibit/ expel/ suspend me from being involved in any capacity in all cricket activities in South Africa conducted/ held under the auspices of Cricket South Africa and its Provincial Affiliates and member affiliate Clubs and Schools at a National, Provincial and Regional level.
